Summary of Significant Career Events

- (1) In May 1966 failed the eye test during the annual flight physical while deployed. Appealed to a Board of Flight Surgeons in Washington, DC, and became the first Naval Aviator to receive a waiver to remain in Service Group 1 while wearing glasses. This later became the norm.
- (2) In November 1966 led the first strike conducted against two surface-to-air missile sites in North Vietnam.
- (3) In December 1967 while leading a strike against the Kien An Highway Bridge, North Vietnam, his aircraft sustained a direct hit that destroyed both hydraulic systems and rendered the control stick useless. With the stabilator locked in a full nose up position he flew the aircraft through a series of high G, rudder controlled barrel rolls out of enemy territory before ejecting safely with his RIO over the Gulf of Tonkin. They were rescued by helicopters from the North SAR destroyer.
- (4) In April 1968, while attacking a munitions cave storage area near Dong Hoi, North Vietnam, his aircraft sustained a direct hit from automatic anti-aircraft batteries and caught fire. With one engine out and the fire consuming the aircraft he headed for the coast five miles away. With systems failing and smoke in the cockpit he lost control of the aircraft as he crossed the coast and ejected safely with his RIO. They were rescued by helicopters from the South SAR destroyer.
